
Please be sure that the following items are included on the application A site visit will not be made without a complete application.

| Page 1: Permit Application for Soil Erosion and Sedimentation Control |

| Section 1: Provide the Name, mailing address and phone numbers of Applicant. |
| Section 2: Provide the Name, mailing address and phone numbers of the Landowner. (This is the same as Section 1 if the landowner is the applicant) |
| Section 3: Provide the Name, mailing address and phone numbers of your Contractor Excavator. (The Person or Entity responsible for earth change activity) |
| Section 4: Provide the Township, street address, and tax ID number of project. (Include Section, Town and Range, subdivision and lot number as appropriate.) |
| Section 5: Provide the MDEQ Permit Number if applicable or the date you applied for your MDEQ permit. |
| Section 6: Check type of project and describe work to be completed. The area to be disturbed must be flagged before site visit will be completed. Indicate the size of area to be disturbed in acres or square feet. Indicate distance to the closest water body or wetland and provide anticipated start and completion dates. |
| Section 7: Provide name and phone numbers of on-site responsible person. |
| Landowners signature or Designated Agent signature with proper authorization is required. |
| Page 2: Directions and Site Plan |
| If engineered plan is provided include plan preparer's name and phone numbers. |
| Provide clear directions to the site. Include a map if necessary. |
| Draw or attach Site Plan (overhead view) showing all earth change activity including spoil placement and landscape work needed to complete the project and location and distance to water. |

VIOLATIONS

After the fact - Construction begins before permit is issued - Double fee may be imposed.
